NOTICE OF CLOSURE OF BANK ACCOUNTS, POST OFFICE ADDRESSES, DOMAIN NAMES, EMAIL ADDRESSES FOR THE TWO MERGED INSTITUTIONS OF UGANDA ALLIED HEALTH EXAMINATIONS BOARD AND UGANDA NURSES AND MIDWIVES EXAMINATIONS BOARD.

Greetings from the Uganda Health Professions Assessment Board (UHPAB).

The Technical and Vocational Education and Training Act of 2025 (TVET Act 2025) was enacted as Act No. 3 of 2025 on **27**th **January, 2025.** It was subsequently gazetted under Statutory Instrument No. 25 of 2025 on **14**th **March, 2025.** The Minister responsible for TVET appointed the **15**th **March, 2025** as the commencement date of the Act, making it operative/effective on that date.

Section 77 (2) (b) of the TVET Act established the "Uganda Health Professions Assessment Board" with its mandate highlighted in Section 77 (6) as "Assessment and Certification of Health Professionals under the Technician Vocational Education and Training". Additionally, Section 77 (4) of the TVET Act merged Uganda Allied Health Examinations Board and the Uganda Nurses and Midwives

Uganda Allied Health Examinations Board and the Uganda Nurses and Midwives Examinations Board to form the Uganda Health Professions Assessment Board (UHPAB).

In view of the above, I wish to inform you that Uganda Allied Health Examinations Board (UAHEB) and Uganda Nurses and Midwives Examinations Board (UNMEB) no longer exist. I therefore wish to notify you that all Bank Accounts, Post office addresses, Domain names, email addresses and Logos operated and used by the merged institutions of Uganda Allied Health Examinations Board (UAHEB) and the Uganda Nurses and Midwives Examinations Board (UNMEB) shall be closed and therefore cease to be operational / recognized on the **30th June, 2025.**

In the interim, the Uganda Health Professions Assessment Board (UHPAB) shall continue to offer services to its stakeholders through its two Secretariat offices located on Plot 157, Ssebowa Road Kiwatule and its other office on Kisosonkole Road, Plot 920, East African Road Upper Estate Parish Kyambogo.
